## Case Study

#### BASF, Bradford and Grimsby

**Projects Overview**: both BASF sites manufacture chemical products used in various industrial processing applications and as such, working within these COMAH (Control of Major Accident Hazards) regulated environments requires the highest levels of safety.

At the Bradford site we supported our group company, Richard Alan, on a new plant installation and contributed to a significant safety milestone of 100,000 man-hours without a single Lost Time Accident (LTA) during work on the project.

Our scope of work included the erection of access towers and lifting frames, which involved challenging confined space working around existing plant.





## Case Study

#### The Majestic, Leeds

**Project Overview**: this iconic Grade II listed building in the heart of Leeds city centre, was badly damaged after fire ravaged it in 2014, leaving an unstable shell with no roof. Over 2 years the building was made watertight with a temporary roof and dried out with ventilation ducting. Scaffolding Access Solutions erected and maintained the vast and complex access and load bearing platforms within the multi-level site.
